# Council clears the way for Profile patrols

As reported in the Scunthorpe Telegraph during November, Barton Town Council has agreed a deal with Profile Security Services to patrol the town centre.

Residents in the North Lincolnshire spot are reluctant to spend time out on the town, while landlords and restaurant owners are worried, too. One barmaid interviewed by the newspaper was quoted as saying, "A lot of people don't go out because they are scared, so it will be good when they bring [the patrols] back again".

Two Profile Security Officers will provide a reassuring presence on Friday nights

and Saturday mornings, between the hours of 10.00pm and 2.00am. The four-week trial will be in place on the run up to Christmas. Profile's street wardens will be working in conjunction with CCTV surveillance, the Police and the local community.

Profile Area Manager **Travis Peters** commented, "It's a pilot set up to improve people's perceptions of coming into the town". The initiative was set up following a meeting between Barton Town Council and the Safer Neighbourhoods Partnership. The success of the scheme will be reviewed on the 7th of December.

### SIA set for a facelift



There's still little word about the changes security experts and their clients can expect when the industry's watchdog, the Security

Industry Authority, undergoes what the Government are calling "a phased transition to a new regulatory regime".

No major changes are expected until after next year's London Olympics have taken place and the last of the medals have been handed out. Central to the reforms is fresh legislation that will see a new regulatory body set up, independent of state control.

Public consultation will continue into next year. The name 'SIA' is likely to remain, but the new body will introduce a number of key measures.

#### So what's the difference?

The big change is that the regulator will license private security businesses in designated areas. It will be a criminal offence for a security business to operate without a licence – or without individual registration for self-employed professionals.

To register, the new body will need confirmation of an individual's identity, address history, right to work, qualifications and so on through authorised businesses and other partners as yet unconfirmed.

Once an existing licence expires, individuals will only pay a registration application fee and an annual subscription expected to be lower than current levels.

#### What about the Approved Contractor Scheme?

With so much time invested in the ACS, an approval scheme will remain in place. Fit and proper criteria such as British Standards will continue to be minimum requirements, while voluntary quality criteria will earn security companies the hallmarks that buyers and government bodies look for.

Profile's Compliance and Training Director **Mick Austen** commented, "We'll hear more in the coming months as the consultation process moves forward. For now, regulations and processes remain the same, as will the high standards we set ourselves." Silhouette and the Profile website will keep you posted with developments.
